

The site is presently used by the Cricket Club with 2 adult teams, and youth teams and training sessions. This is available to all the village, as well as sportsmen from outside the village. The site is also used for many community events such as the Fireworks Display, Beer Festival fun day, and for school outside activities. |

| | This site is fully accessible to the public with 2 public footpaths crossing the site. It is used by residents exercising their dogs on a regular basis. It is used for many community events during the year being the only large accessible green that is available in the village. The site is bordered by Harpers Brook on the north side. During periods of flooding, parts of the field do go under water acting as flood plain. The levels soon drop and the field quickly becomes usable again. The primary school which is located off Bridge St does not have its own playing field and uses the Meadow as its main exercise and games area. Without this, the school would not manage to provide adequate sports events. |

Draft Supporting Text

National policy makes provision for local communities to identify green areas of particular importance to those communities, where development will not be permitted except in very special circumstances. The following sites have been designated as Local Green Spaces through the Neighbourhood Plan consultation process:

Policy B11: Local Green Spaces

The following sites have been designated as Local Green Spaces:

The Meadow

The Park

Rectory paddock and allotments

Benefield Road allotments

Development that would harm the openness or special character of a Local Green Space (as designated on the Polices Map) or its significance and value to the local community will not be permitted unless there are very special circumstances which outweigh the harm to the Local Green Space.
